Enclosed please find the records from P2005-100 as requested in your letter received on March 23, 2012. The request resulted in 149 pages at \$0.15 per page. Please remit \$22.35 to the Adirondack Park Agency at the address below.

Records that were previously shared with all parties to the hearing have not been included with this response. The Agency's review of these records, many of which are included in the 23,000 page hearing record, was time consuming and comprehensive.

The Agency has no mechanism to search for the records you have requested in Item #1 and #2 of your letter. However, the cover memo to the "Guidelines for Biological Survey" has been included.

Also not released in response to your request are inter-agency or intra agency materials that are not: (i) statistical or factual tabulations or data; (ii) instructions to staff that affect the public; (iii) final agency policy or determinations; or (iv) external audits, including but not limited to audits performed by the comptroller and the federal government. Such materials are exempt from release pursuant to §87(2)(g) of the Public Officer's Law.

Additional records not provided in response to your request are exempt from release pursuant to §87(2)(b) of the Public Officer's Law, as disclosure of these records would result in an unwarranted invasion of personal privacy as defined in §89(2)(b) of the Public Officer's Law.

Re: Appeal of Partial Denial of FOIL Request

No. 12-3-14

Dear Ms. Reynolds:

Pursuant to 9 NYCRR § 587.1(i), Protect the Adirondacks! Inc. and Sierra Club hereby appeal the partial denial of FOIL request No. 12-3-14. This appeal includes all records that are within the scope of the FOIL request to which access was denied and which were not provided to the undersigned.

Pursuant to the Freedom of Information Law, Public Officers Law Article 6 ("FOIL"), on March 23, 2012, I filed with Brian Ford the above-referenced FOIL request on behalf of this firm's clients, Protect the Adirondacks, Inc! and Sierra Club.

The request was partially denied by Mr. Ford, in a letter dated July 6, 2012. The alleged grounds for denial were that the unreleased records were not releasable under Public Officers Law \$87(2)(g), \$87(2)(b), and \$89(2)(b). Copies of the FOIL request and APA's partial denial are enclosed.

We hereby appeal this determination on the grounds that the denial was vague and failed to enumerate the individual documents withheld. The denial also failed to disclose which exemption applied to each individual document withheld. The general nature of the denial is overly broad and does not meet the Agency's burden of proof to demonstrate that the records are exempt from disclosure.

Under <u>City of Newark v. Law Department of the City of New York</u>, 305 A.D.2d 28 (1st Dept. 2003), the agency withholding the records may not rely on a "blanket invocation" of the statutory exemptions. Instead, it must enumerate or describe the documents withheld and offer specific bases for the claims of exemption. <u>Id.</u>, at 33-34.

Mr. Ford's refusal to release the records simply quoted the Public Officers Law and offered no specifics. As such, it did not meet the requirements of the law. To remedy this inadequacy, I respectfully request you to review and release all of the documents which have been withheld, in accordance with FOIL.

Any claimed exemptions must be reviewed in light of the policy that the exemptions to FOIL shall be narrowly construed. Capital Newspapers v. Whalen, 69 N.Y.2d 246, 252 (1987). Moreover, all government records are presumptively open to the public unless they fall squarely within one of the enumerated FOIL exceptions. Gould v. New York City Police Department, 89 N.Y.2d 267, 274 (1996). These exceptions are to be "narrowly construed, with the burden resting on the agency to demonstrate that the requested material indeed qualifies for exemption." Id., at 275.

As required by 9 NYCRR § 587.1(i)(8), please respond to this appeal within 7 business days. If access to the records is denied on appeal, please explain the reasons for the denial fully in writing, as required by law, for each and every record withheld.

In addition, please be advised that the Freedom of Information Law directs that all appeals and the determinations that follow be sent to the Committee on Open Government, Department of State, One Commerce Plaza, 99 Washington Avenue, Suite 650, Albany, New York 12231
